## Non-Permanent Residents, as of July 1, 2023

Released by Statistics Canada - September 28, 2023

According to estimates released today by Statistics Canada, there were 1,446 non-permanent residents living in Yukon as of July 1, 2023. This represents an increase of 478, or 49.4%, compared to July 1, 2022 (968 non-permanent residents).

Comparing July 1, 2023 to July 1, 2022, the number of non-permanent residents in all provinces and territories increased. Proportionally, Yukon's increase was the seventh highest in the country.

Of the 1,446 non-permanent residents living in Yukon on July 1, 2023:

- 1,120, or 77.5%, were work permit holders;
- 217, or 15.0%, were study permit holders;
- 80, or 5.5%, held both work and study permits; and
- 29, or 2.0%, were in other categories, mainly family members living with permit holders.

There were no asylum claimants living in Yukon as of July 1, 2023.

## Note to readers:

- A non-permanent resident refers to a person from another country with a usual place of residence in Canada and who has a work or study permit or who has claimed refugee status (asylum claimant). Family members living with work or study permit holders are also included unless these family members are already Canadian citizens, landed immigrants (permanent residents), or non-permanent residents themselves.
- This is an estimate of the number of non-permanent residents in Canada, and differs from the number of
  asylum claimants and temporary residents from the Department of Immigration Refugees and Citizenship
  Canada (IRCC). Care should be taken to consider the differences in methods and reference dates when
  comparing data from IRCC with Statistics Canada demographic estimates. The two data sources are not fully
  comparable.
